

**EMERGENCY RESOURCES**

Hurricane Sandy has taught us a lot about the need for preparedness. These are some resources that will be useful to you. The following is a selection of emergency resources to help you plan ahead.

**FEDERAL RESOURCES:**

**Small Business Administration (SBA):** The U.S. Small Business Administration (SBA) is a governmental agency in service of small businesses. Information and forms for the SBA's low interest disaster loans. Loans can be used to replace goods and property that have been damaged or destroyed due to a disaster. The SBA provides support to small businesses and small business owners across the nation with obtaining small business loans, ensures that federal contract dollars go to small businesses, and provides counseling for business guidance. <http://www.sba.gov/category/navigation-structure/loans-grants/small-business-loans/disaster-loans>

**FEMA (Federal Emergency Management Agency):** The FEMA is the federal agency in charge of coordinating all federal disaster relief efforts. Individuals who have suffered losses due to a disaster must register with the FEMA if they seek federal assistance. Nonprofit organizations may qualify for aid with re-building if the facilities they own or operate have been damaged as a result of a disaster. <http://www.fema.gov/about/regions/regioni/index.shtm>

**The Disaster Assistance Improvement Program:** Federal disaster resources with information, support, services and a mechanism to access and apply for disaster assistance through collaborative, data-sharing efforts between federal, tribal, state, local and private sector partners.
