LOWER MANHATTAN CULTURAL COUNCIL (LMCC) AWARDS EXTENDED LIFE DANCE DEVELOPMENT ARTIST RESIDENCIES:

SUPPORTED BY \$600,000 MELLON FOUNDATION GRANT, ARTISTS WILL RECEIVE MULTI-YEAR FUNDING, STUDIO SPACE, CAREER DEVELOPMENT SUPPORT

Lower Manhattan Cultural Council (LMCC) announces today the inaugural recipients of its newly expanded Extended Life dance development artist residencies, designed to sustain the careers of choreographers with essential financial, administrative and presentation support:

Nora Chipaumire, Beth Gill, Maria Hassabi, Sarah Michelson, Jennifer Monson, Okwui Okpokwasili, Pam Tanowitz and David Thomson. Thanks to a generous \$600,000 grant from The Andrew W. Mellon Foundation, resident artists will receive multi-year funding, studio space and career development support throughout the course of their residencies.

The goal of Extended Life is twofold: to extend the lives of ephemeral, essential works of dance, and to advance the creative lives of the artists themselves through a new framework where institutional collaborations are key. The residency enables choreographers to expand and experiment with their existing works, present them in both traditional and site-based venues, and develop strong, collaborative partnerships with local partners and national presenters.

Building on the successes of the past five years of LMCC's previous Extended Life program, the Mellon award enables LMCC to deepen its impact on the lives of choreographers and the dance field by supporting artists through one of two program tracks over three years. The **Lifeline track** offers career support in the form of an annual \$15,000 financial stipend and residency development space, while the **project-based track** includes commissions, studio space and production funds.

In total, LMCC's Extended Life program scaffolds the practices and careers of mid-career choreographic artists by enriching their livelihoods and growing their audiences through intense focus on the development process and public life of their works. Throughout the residency, participating artists will collaborate with LMCC and other cultural institutions to share knowledge of artistic sustainability and advance the field through their work and research.

Of the residencies **Lili Chopra**, LMCC's Executive Director of Artistic Programs, says, "We are thrilled to provide vital support to choreographers to continue expanding on their craft and impacting the lives of others through their art."
